The female did have visible injuries and the male was arrested for Domestic Violence and Assault. Nothing further to report.

**Domestic Violence**

On 12/20/19 Officers responded to [REDACTED] in reference to a disturbance. Upon arrival, Sgt Burns and I stood out front of the residence and heard a male and female screaming inside. After several minutes of arguing, the male, later identified as Tyler Glockner, walked through the kitchen followed by the female, Kelly B [REDACTED]. As Tyler and Kelly were walking through the kitchen, I heard Kelly tell Tyler that he needed to leave because he just "kicked the shit out of me". Sgt Burns and I made contact with Tyler as he was walking out of the front door. Tyler was very emotional and intoxicated. I asked Tyler what went on and he stated that he and Kelly were arguing and she wanted him to

leave. I questioned Tyler about what Kelly said when he was walking out of the door but he continued to deny anything being physical. Tyler indicated he and Kelly were drinking and got into an argument. Tyler said Kelly wanted him to leave the house so he was going to the Comfort Inn where he already had a room. As Tyler was leaving, he was stopped by Sgt Burns and I. Kelly stated that she and Tyler were drinking and not getting along. Kelly went and got into the shower. When Kelly was in the shower, Tyler attempted to get in the shower with her so she pushed him back. Kelly stated she was able to finish her shower and then went out in the living room. Once in the living room, Tyler continued to argue with her and at one point punched her in the stomach so she punched him back. Kelly stated Tyler said "oh you wanna hit me" and then punched her in the face. Kelly fell down and Tyler grabbed her by the hair and spun her around. Kelly had visible injuries under her left eye and on her left knee. Kelly declined to speak with New Directions and also declined to fill out a statement. Kelly said several times she did not want to get Tyler in trouble. Tyler was arrested for Domestic Violence 2919.25A and Assault 2903.13A and transported to the Knox County Jail without incident.
